MEMBERSHIP QUORUM BY-LAW SUGGESTED CHANGE

Reason/Need for Proposed By-law Change:

As a result of the last membership meeting and a tally of the membership/farms, we discovered we may run into the problem of not having quorum for our regular meetings, for amendments to by-laws, and for elections since it is based on a percentage of the total number of ranches. Below are the current references to quorum from our by-laws. It is the board's recommendation to change the Membership Qualifications by-law with regard to voting and non-voting membership by "activating" the membership when a meeting is attended. All other rewards of membership will remain the same for both voting and non-voting annual memberships; this is just to remedy the quorum issue. (*Example 1:* A regular monthly meeting is held and 16 people are present representing 7 farms. If we have 50 membership farms x 20% = 10. This does not meet quorum. *Example 2:* Election of Officers: if we take the same 50 farms x 33% = 17 farms.)

ELECTIONS OF OFFICERS

- a) The Officers shall be elected every two years, by a quorum vote of the Membership at the November meeting, which is designated as the "Election Meeting."
- b) Quorum is defined as one-third of the membership.

QUORUM

Twenty percent (20%) of members who are eligible to vote shall constitute a quorum at any meeting. If a quorum is not present, the members present, by majority vote, may adjourn the meeting to a future time.

ARTICLE XV. AMENDMENTS TO THE BY-LAWS

- Section 1. These by-laws may be altered by amendment, repeal, or addition by the majority vote of the membership of the FALA at any regular or special meeting of the membership, provided a quorum of the membership is present at such meeting.
- Section 2. Amendments to the By-Laws must be approved by the membership by written ballot.
- Section 3. A change in the by-laws must be approved by majority vote of the members actually voting.

CURRENT WORDING:

ARTICLE V MEMBERSHIP QUALIFICATIONS

Section 1. There shall be five types of membership:

a) Annual — Any individual, family, farm or corporation with a sincere interest in llamas, alpacas or other camelids shall be eligible to become a Member. An Annual membership shall be granted upon written application accompanied by annual dues, submitted to the FALA Treasurer.

ARTICLE V MEMBERSHIP QUALIFICATIONS

- Section 1. There shall be five types of membership:
 - a) Annual Any individual, family, farm or corporation with a sincere interest in llamas, alpacas or other camelids shall be eligible to become a Member. An Annual membership shall be granted upon written application accompanied by annual dues, submitted to the FALA Treasurer. <u>All Annual Memberships are considered inactive/non-voting; and therefore, do not count against the quorum until the membership is "activated" by attending a meeting during that calendar year. All other membership benefits will remain the same for both voting and non-voting members.</u>

AgriTourism Sign Information and Pre-Orders

UPDATE: Only 2 more needed to meet the 50-order minimum

Many farms and ranches conduct educational Alpaca Days and Open House Days for the public. Agriculture Secretary Bill Putnam wishes to encourage the farm and ranch lifestyle and has been a proponent of the Agri-Tourism bill which passed and became part of the Florida State Statutes.

You may have seen the Equine Signs posted on horse farms throughout the state; well, this statute provides for agritourism ventures. You will need to post a sign on your property. There are specific wording and directions for the sign and where to post on your property.

We have requested and received a few quotes from sign printers and the best quote for the sign is 50 signs for \$12 each, or 100 signs for \$10 each. This does not include tax. Before we order the signs we need to have committed pre-orders for them as we do not wish to maintain an inventory of unsold signs. If you wish to purchase the signs, as noted in the Statute, each farm/ ranch will need to post a minimum of two (2) signs; one at the entrance to the property and one where the "tour" takes place (gate to your pasture, etc.). The notice of inherent risk sign must consist of a sign in black letters, with each letter a minimum of one (1) inch in height, with sufficient color contrast to be clearly visible. I would like black letters on a white background, like the Equestrian Warning signs, you may have seen.

RESCUE RUMINATIONS






